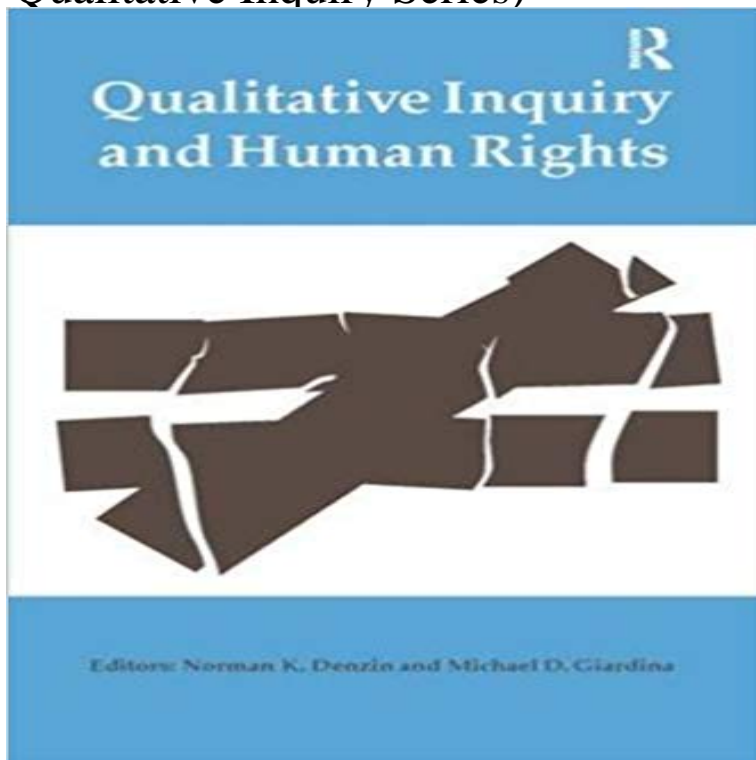


# Qualitative Inquiry and Human Rights (International Congress of Qualitative Inquiry Series)
