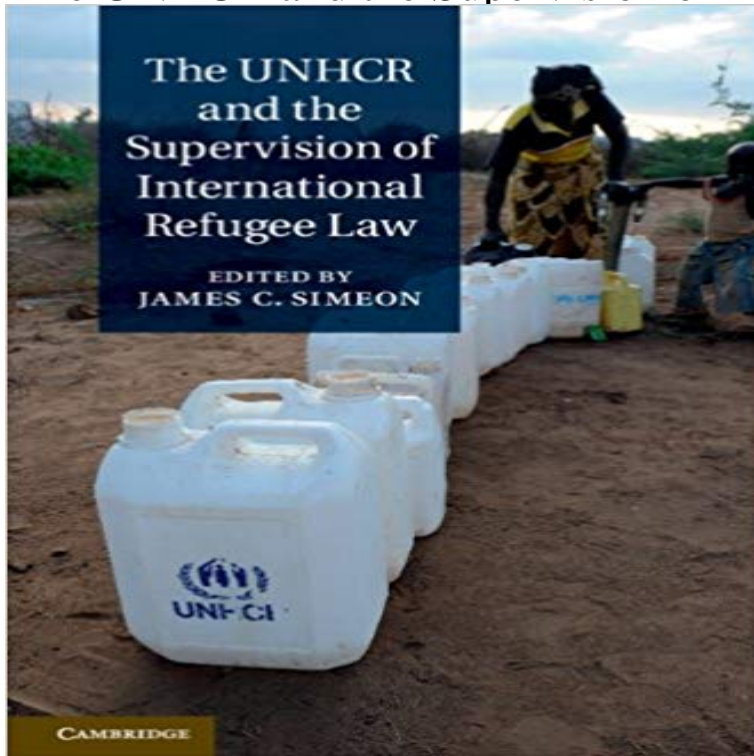


# The UNHCR and the Supervision of International Refugee Law
