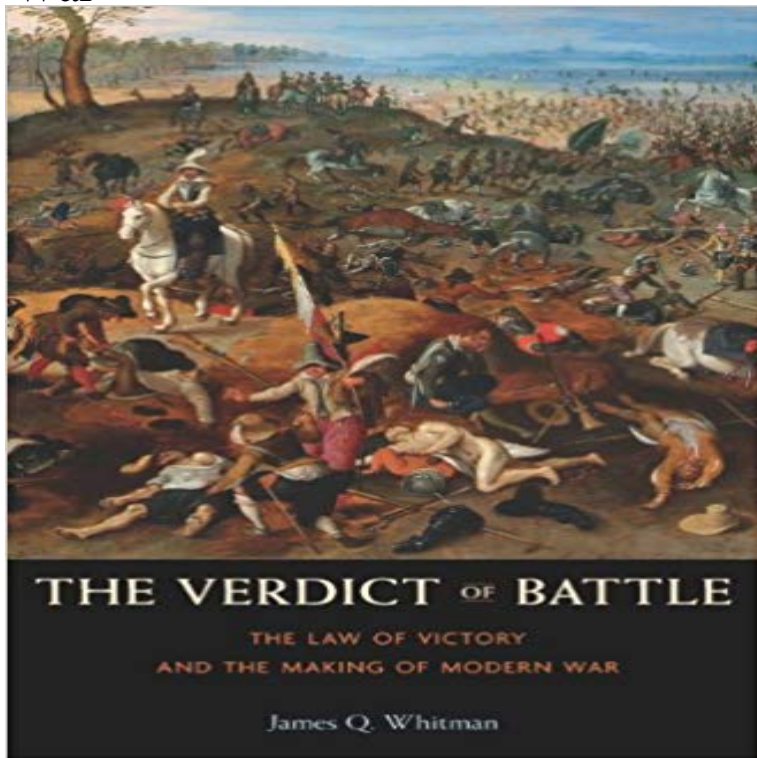


The Verdict of Battle: The Law of Victory and the Making of Modern War
