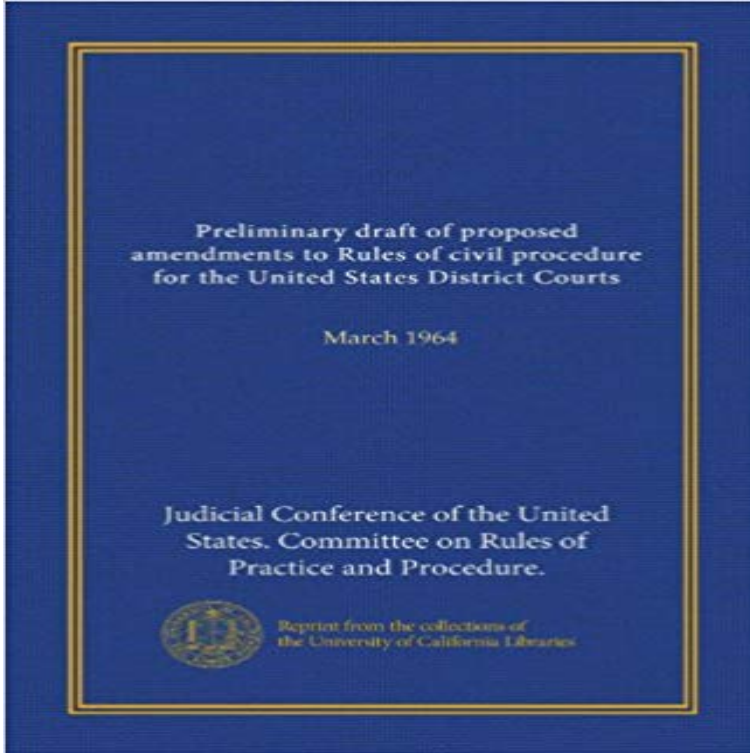


Preliminary draft of proposed amendments to Rules of civil procedure for the United States District Courts (Vol-1): March 1964
